Now in its Ninth Edition, the **CECA Code Course is based on the changes as reflected in the 2017 NEC®** and meets the requirements of the North Carolina Board of Examiners of Electrical Contractors (NCBEEC) for non-classroom continuing education and the Virginia Department of Professional and Occupational Regulation (DPOR) for continuing education.

- ❖ **Tests are available online at www.cecacodecourse.com for \$36 per 4 hour course (3 hours for VA)**
Test has sample questions to show how it works, you may log in and out of the tests as many times as needed before completion and you will immediately see if question was answered correctly.
- ❖ **If you prefer to take the test in paper form, it is available for \$40 per 4 hour course (3 hours for VA) and \$50 for both NC and VA.**

For Paper Format Tests to be mailed to you:

The CECA Code Course manual and the number of tests you purchase will be mailed to you. You will study the text along with the included material from the 2014 NEC®, take the test(s), and return the answer sheet(s) to our office. We will grade the test(s), report hours to the North Carolina Licensing Board and/or the Virginia DPOR electronically, and mail you a completion card.

- Please send the CECA Code Course Manual and 3 tests (*12 hours of non-classroom continuing education). Enclosed is **\$120** or charge to my credit card as per the information below.
 - Please send the CECA Code Course Manual and 2 tests (*8 hours of non-classroom continuing education). Enclosed is **\$80** or charge to my credit card as per the information below.
 - Please send the CECA Code Course Manual and 1 test (*4 hours of non-classroom CE for NC and 3 hours for VA*). Enclosed is **\$40** or charge to my credit card as per the information below.
 - I have included the **\$10** to have my credit also reported to the Virginia Department of Professional and Occupational Regulation (DPOR).*
- *One test is sufficient for continuing education requirements for Virginia and Virginia does not allow the banking of hours for future years.
