* Tests can be taken online at www.ceca-code-course.com at a 10% discount. You may log in & out of the online test as many times as needed before completion. You will immediately see if question was answered correctly. Pay only after you successfully complete the test. For each question, the screen will show the 2020 NEC passage, the question and the 4 multiple choice answers.

Virginia no longer recognizes the online test. For CE credit in VA, tests must be taken in paper format.
